For both Business Management and Accounting and Finance programmes the minimum standard is 'C' in SPM English (1119), 'C' in GCSE English, 'A' in IGCSE English as a Second Language or 6.5 in IELTS (with a minimum component score of 5.5). We will accept an equivalent standard in other qualifications approved by the University for entry to our programmes.

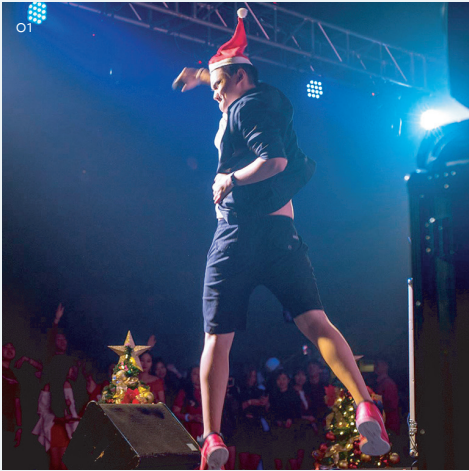
